Currently, all foreign nationals who wish to newly enter Japan are required to apply for visa, except for those possess re-entry permit.

Please note, due to the impact caused by the COVID-19 pandemic, the visa approval procedure may take longer than usual.

- (3) Spouse or child of a foreign national who has a Status of Residence of "Long-Term Resident" whose family is staying in Japan and who has been separated from the family: Please obtain a Certificate of Eligibility and contact VFS Global in
- (4) A foreign national who is about to acquire the Status of "Medical Services", and who contributes to the strengthening Japanese medical systems:
